Thank you for your Baptismal enquiry.

We ask you to complete the registration form (one for each child) and return with a **copy of each child/s Birth Certificate**. Please be advised that one of the Parent **MUST BE** a baptised Catholic and as for the Godparents, one of the Godparent **MUST BE** a baptised Catholic and you would need to provide a **copy of a Baptism certificate for the Godparent**. **If you have more than one Godparent and they are not a baptised Catholic, then they would have to be a baptised Christian from the following Churches:**

(The Anglican Church of Australia, The Greek Orthodox Church of Australia, The Lutheran Church of Australia, The Presbyterian Church of Australia and The Uniting Church in Australia)

Please return these forms as soon as possible to confirm your booking. In order for registration to be complete this form must be signed by both parents, this includes the family law form. These forms are best return by email to stthomas@bne.catholic.net.au.

These forms will not have the date for your child's baptism, this date as well as the date for Baptismal preparation will be given to you upon the return of the completed registration forms. Baptisms are held on 2nd and 4th Sunday's of the month at 10:00am, with the Baptismal Preparation session taking place on the first Monday of the month unless it is a public holiday then the session is to be moved to another day. Baptismal preparation sessions are held in the parish office at 11.00am. If you are unable to attend the Baptism preparation session, please email the parish office (stthomas@bne.catholic.net.au) as soon as possible.

A baptism candle is required for the ceremony. You can purchase a candle from the Parish office for a sum of \$10.00.

Whilst there is no fee for the Baptism, a contribution of \$50.00 for Priest and \$50.00 for the church (and a further \$50.00 for each child being Baptised) is greatly appreciated. For example:

If you have one child being baptised the contribution would be \$100.00 (\$50.00 for the parish and \$50.00 for Priest).

If you have two children the contribution would be \$150.00 (\$50.00 for the parish and \$100.00 for Priest).

If you have three children the contribution would be \$200.00 (\$50.00 for the parish and \$150.00 for Priest).

Please bring this contribution in an envelope label with your child's name to the Preparation session. Please note that contribution payment is CASH only, no EFTPOS facilities available.
